This course will provide a general review of retinal vascular occlusive disease including the clinical manifestation. An understanding of who may be at risk for this disorder will be discussed. The lecture highlights the method for making the proper diagnosis, the management and follow-up schedule of RVO and RAO. Appropriate treatment and preferred practice guidelines will be presented.

GLP-1 receptor agonists, commonly used for Type 2 diabetes and obesity, have been linked to various ocular side effects, including NAION, diabetic retinopathy, macular changes, IOP fluctuations, refractive shifts, and dry eye. While these medications provide important systemic benefits, careful eye monitoring—especially for high-risk patients—is advised. This course reviews GLP-1 RA pathophysiology, explores their ocular effects, and highlights illustrative case examples.






