This course will introduce the primary eye care practitioner to the history, indications, and future of routine and complex anterior segment disease and surgery. This course will provide a wide array of optometrically referred clinical case presentations for consultation and treatment. The course will present multiple anterior segment cases providing instructive information on surgical options used. Clinical cases will highlight the historical risk factors for infectious keratitis as well as onset, and clinical pearls providers should be aware of when considering the differential diagnosis for corneal ulcers. The course will review the various causes of infectious keratitis, including, but not limited to, bacterial, viral, fungal, parasitic infections. We will describe the pertinent historical and risks factors, mechanisms to acquire infections, as well as the clinical signs and symptoms of infectious keratitis. We will review the various pharmacological treatments for infectious keratitis, not only topical but also oral medications and the role of label cross-linking as well as indications for cornea transplantation as a role in the treatment of corneal ulcers. This course will review the management of patients' expectations regarding the timing of treatment as well as long-term vision rehabilitation during surgery and their refractive outcomes.
